Mr. Selby ask Director Williams to explained proposal 83.25 on why the effective date differs for the precincts in the same polling locations.

Director Williams explained that RW09A precinct will be in the Special Election, Senate District 21 of August 26th and RW09 was not. (RW09 is in State Senate, District 56)

Chair Allen commended **Director Williams** on providing maps of the changes that outlined the impacted areas.

Mr. Selby inquired about the criteria for polling precincts.

Director Williams outlined the criteria:

- ADA compliance
- Parking
- Large space
- Survey of Electrical
- Feedback from citizens and poll workers

Ms. Adams expressed concerns about voter participation and voters receiving notice of the precinct changes.

Director Williams explained that precinct cards are required to be mailed per election code, and the precincts with changes will have 4'x4' signs to indicate the change at that location.

Chair Allen entertained a motion to approve the listed polling place changes. The motion was made by **Mr. Selby**, seconded by **Mrs. Crawford**, and carried by a unanimous vote of 5-0.

Director Williams explained the process to **Mr. Selby** as they moved around the room.

OLD BUSINESS

#3- REVIEW OF ELECTION MATERIAL (PRE-CERTIFICATION DOCUMENTS)

Director Williams explained the SOVC changed to include (14) undervotes.

An undervote occurs in an election when a voter chooses not to select any candidate or option in a particular race or contest on their ballot, even though they participate in the election overall.

Chair Allen asked the Board what time they would like to begin discussions of certification.

Mr. Heekin suggested 4pm to determine next steps.
